Objectives:

The objective of this course is that students acquire in-depth knowledge of the contemporary legal challenges for regulation of the internal market, to develop the ability of understanding the legal literature on a higher level of complexity and in-depth understanding of legal issues related to the operation and future of the EU internal market.
