**Vsebina:**

- Individualno raziskovalno delo 2 pomeni vključitev v projekt in raziskavo problema pod vodstvom mentorja kot pripravo za doktorsko nalogo.
- Študent se podrobneje seznanja z načinom izdelave doktorske naloge, predela okvirno literaturo in oblikuje osnutek dispozicije doktorske disertacije.
- Študent osnutek dispozicije zagovarja pred komisijo – prvi doktorski seminar.

**Content (Syllabus outline):**

- Individual research work 2 means that the student takes part in a project and research of a particular problem with support of the supervisor, as preparation for a Ph.D. thesis.
- Student gets acquainted with the procedure of thesis writing, studies basic literature and prepares a proposal of a Ph.D. thesis.
- Student defends the proposal of the thesis before a committee – first doctoral seminar.

**Temeljna literatura in viri / Textbooks:**

- Strokovna in znanstvena tekoča periodika s tistega pravnega področja, na katerem bo študent izdelal doktorsko disertacijo. / Professional and scientific literature in a field of law where the student prepares a Ph.D. thesis.

**Cilji:**

- Cilj IRD 2 je, da študent pripravi osnutek dispozicije doktorske disertacije in ga zagovarja pred ustrezno tričlansko komisijo, ki pregleda osnutek dispozicije, zlasti problem, cilje in hipotezo. Pri tem komisija presodi, ali:
- iz predložene dispozicije in njenega zagovora izhaja, da ima kandidat dobro splošno poznavanje in razumevanje tematike;

**Objectives:**

- The goal of individual research work 2 is for the student to prepare a draft proposal of the PhD thesis and to defend it in front of a three-member committee that verifies the draft, particularly the problem, goals and hypothesis. In this respect the committee verifies, whether:
  - the written work and interview show that the candidate has a good overall knowledge and understanding of the subject;

- kandidat je sposoben samostojnega raziskovalnega dela na visoki ravni;
- cilji raziskovalnega dela so realistični in dovolj konkretno opredeljeni;
- kandidat izkazuje, da je zbral in prebral dovolj širok obseg literature in virov ter jih kritično analiziral;
- v dispoziciji predlaga ustrezno metodologijo dela;
- opredelil se je do omejitev raziskave;
- razvidno je, kako bo dispozicijo razvil v doktorsko disertacijo;
- kandidat izkazuje znanstveni pristop k raziskovalnim vprašanjem in sposobnost poglobljenega načina dela;
- raziskovalna tema in obravnava le-te ni v nasprotju z etičnimi standardi raziskovalnega dela;
- kandidat ima ustrezno aktivno in pasivno znanje jezika, v katerem naj bi nastala doktorska disertacija, kot tudi ustrezno pasivno znanje jezikov, v katerih je relevantna literatura za doktorsko disertacijo;
- kandidat je podal razumen časovni načrt za izvedbo raziskovalnega dela na doktorski disertaciji;
- PF UM lahko kandidatu zagotovi ustrezne razmere, vključno z mentorstvom, za nadaljevanje raziskovalnega dela na predstavljeni tematiki;

- the student is capable of carrying out advanced research;
- the aims of the research are realistic and focused;
- evidence of wide reading and critical analysis;
- appropriate methodology and research techniques are proposed;
- limitations to the research are addressed;
- it is clear how the research will develop for a PhD thesis;
- the candidate shows a scholarly and rigorous approach to research issues
- the research topic and treatment meet the ethical standards for research;
- competence in both written and spoken language in which the PhD thesis is to be written and defended as well as suitable written language of the languages that are relevant for the PhD thesis;
- there is a suitable timetable for the research for the PhD thesis;
- the University has adequate facilities (including supervision) to enable the research to progress
