Content (Syllabus outline):

IRD 5 presents publication of the results of the scientific research of the doctoral candidate in relation to the doctoral dissertation in accordance with the criteria of the University of Maribor for the scientific activities of the candidates in order to obtain a doctorate before promotion. .

Temeljna literatura in viri / Textbooks:

- Strokovna in znanstvena tekoča periodika s tistega pravnega področja, na katerem bo študent izdelal doktorsko nalogo. / Professional and scientific literature in a field of law where the student prepares a Ph.D. thesis.

Cilji:

- Objava izsledkov raziskovalnega dela v okviru doktorskega študija na način, ki ga pravna znanost priznava kot relevantnega in ki po merilih Univerze v Mariboru veljajo kot pogoj za promocijo doktorjev znanosti.

Objectives:

- Publication of the results of the research work performed under the doctoral studies, in a manner that is considered as relevant by the legal science and which the University of Maribor criteria set as required for promotion of a new doctor of juridical science.

Predvideni študijski rezultati:Znanje in razumevanje:

- Znanje širšega strokovnega področja, v katerega sodi doktorska naloga in ožje znanje ter razumevanje pojmovnika, ki ga zajema tema doktorskega dela. Poudarek je na oblikovanju raziskovalnega dela doktorske naloge.

- Strokovno zapisovanje in izražanje vsebine,
- obvladovanje reševanja strokovnih problemov,
- suverena predstavitev končnih spoznanj, in

Intended learning outcomes:Knowledge and Understanding:

- Knowledge of the broader professional field encompassing the Ph.D. thesis and special knowledge in a glossary concerning the Ph.D. thesis. The emphasis is on the formulation of the research part of the Ph.D. thesis.

Transferable/Key Skills and other attributes:

- Documenting and expressing the subject in a professional way,
- mastering the professional problem solving,
- mastering the presentation of the key conclusions, and
- argumentative skills.

Metode poučevanja in učenja:

- Študent ob pomoči mentorja z individualnimi konzultacijami opravi celotni raziskovalni del doktorske naloge. Mentor na konzultacijah preverja vsebinski in strukturni vidik predvidenih znanstvenih objav ter napredovanje pri raziskovalnem delu.

Learning and teaching methods:

- Student performs with mentor's assistance in individual consultations the complete research part of the Ph.D. thesis. Content, structural aspect and advancement in research are monitored by supervisor during consultations.
